1.	Minimum Eligibility Criteria/ Qualifying Requirement	Page No. 4	<p>Under the Minimum Eligibility Criteria, there is no mention of the specific requirement for minimum number of partners. Our firm meets all the other eligibility criteria mentioned.</p> <p>However, on page 19, under the Evaluation Criteria, it is stated that a minimum of 3 partners from Odisha is required. Could you kindly confirm whether this requirement would lead to disqualification of our firm, given that we do not meet this particular condition?</p>	<p>Minimum of 3 partners from Odisha specified therein is not a disqualification criteria under this EOI. Points shall be allocated as per the Evaluation Criteria specified in ANNEXURE-D of the EOI.</p> <p>Minimum 3 nos. of Partners from Odisha having 2 years of experience are the point allocation criteria against the requirement defined in Sl. No. 2 of the Evaluation Criteria, Annexure-D. For any additional Partners (beyond 3 Partners from Odisha), 2 points shall be allocated irrespective of Partners from Odisha or outside Odisha, accordingly points shall be allocated.</p>

If we do not have any partner form Odisha but have a total of 9 partners, then whether we qualify or we get 12 points for 6 partners (Over 3).</p>	<p>POINT ALLOCATIONS table comprising individual line items are defined in Evaluation Criteria, ANNEXURE-D which is self-explanatory.</p> <p>Minimum 3 nos. of Partners from Odisha having 2 years of experience is the point allocation criteria against the requirement defined in Sl.
