Clause No - BOQ - page 4	Price quoted should be firm, till completion of delivery, on F.O.R. - Destination basis, OPGC, Banharpali MGR Track (Door delivery). Including RDSO design charge & Drawing Approval, RDSO Inspection Charge, RDSO Speed Certificate, P&F, freight charges, transit insurance etc .The agency has to quote FOR (Door Delivery basis) price with detail of breakup of railway charges, freight, inspection, & GST. Rate of GST to be clearly specified for individual charges. Any permission or approval from Railway shall be arranged by the bidder up-to delivery at OPGC Site.
