Qualifying Requirement for those willing to supply suspension bar only

The bidders must meet the following Qualifying Requirements with respect to the below.

1. The bidder must be a Manufacturer or their Authorized dealer/ Stockiest of the materials. Authorization certificate/ dealership agreement forwarded by manufacturer etc. shall be submitted as a documentary proof.

AND
2. Bidder must confirm to supply as per technical specification as stipulated in the tender document (Self declaration to be submitted)

AND
3. Party should have inline experience for supply *similar product directly to any industry. Relevant Order copies of last five years to be submitted in order to satisfy the following.
 - Three purchase orders for supply of similar product and each purchase order value not less than the amount equal to Rs. 3.68 Lakhs in last five years.

'OR'
 - Two purchase orders for supply of similar product and each purchase order value not less than the amount equal to Rs. 4.59 Lakhs in last five years.

'OR'
 - One purchase orders for supply of similar product and each purchase order value similar product and each purchase order value not less than the amount equal to Rs. 7.34Lakhs in last five years.

AND
4. Average Annual financial turnover during the last three Financial Years should be at least Rs. 3.00 Lakh or more. Audited Balance Sheet and profit& Loss A/C must be submitted along with the Techno-commercial Bid.

5. Must not have been disqualified/blacklisted in any public/Govt sector during the last 10(Ten) years for the similar nature of job. (Self Certification)
