### **1.0 Introduction**

1.1 Odisha Power Generation Corporation Limited (OPGC), operates two units of 210 MW at IB Thermal Power Station (ITPS), Banharpali. In addition to that; unit 3 & 4 (2 X 660 MW) are also in operation.

### **1.2 Basic information:**

OPGC is having 2 X 210MW Units having BHEL Supplied TG (KWU Design) and are commissioned in 1994-95. The inter stage seals clearance has gone up and OPGC wants to renew the seals. OPGC would like to carry out the above mentioned re-finishing job at site. Qualified party has to supply the required sealing materials as per OEM (BHEL) standard and has to carryout in-situ refining of the HP module inter stage seals.

### **2.0 Expression of Interest:**

OPGC invites “Expression of Interest (EOI)” from interested parties for the job “In Situ inter stage re-finishing of HP Module for its 210MW (KWU); at ITPS, Banharpali”. Interested parties may clearly indicate the inputs required from OPGC.

### **3.0 Purpose of this EOI:**

4.1 Party must have the credential of doing In-situ finning job for HP/IP/LP Modules of 210MW or above machine.

- 4.2 Completion certificate for the job executed to be submitted or the Contact details of the plant for which the In-situ refining job was carried out to be given.
- 4.3 Party must have carried out minimum five numbers of In situ refining job over last three years.
- 4.4 Party shall not have been black listed by any Govt. or PSU organization in last five year ( Self declaration)
- 4.5 Party must be approved sub vendor of BHEL.
- 4.6 Party must be able to produce material test certificate from NABL approved lab for the material supplied.
- 4.7 The average turnover of party must be above 300Lakh over last three year.
