## **Section I: Invitation of Expression of Interest**

### **A. Brief Description:**

OPGC Phase-I is a 2 x 210 MW sub-critical and OPGC Phase-II is a 2 x 660 MW supercritical power plant located at IB Thermal Power station, Banharpali, Jharsuguda, Odisha, India. The total capacity of station is 1740 MW.

While generating quality Power, OPGC has always been a fore runner in complying with stringent environmental norms. Ministry of Environment, Forest & Climate change, in its gazette notification Dtd: 7<sup>th</sup> Dec. 2015, has amended the Environment (Protection) rules, 1986, which make it binding to the thermal power plants to reduce Sulphur Di Oxide (SO<sub>2</sub>) emission below the prescribed limit, depending upon the Unit size and year of installation of the Power plant.

For the purpose of capturing the SO<sub>2</sub> from the flue gas before emission, Flue Gas Desulphurization (FGD) plants are required to be installed in the flue gas path. In compliance with the above said Gazette notification, OPGC is under way of installation of FGD plant in 2 x 660 MW (OPGC-II) and in near future same is going to be installed for 2 x 210 MW (OPGC-I). From FGD plant, Gypsum will be produced in a huge quantities. Through this EOI, IB thermal power station, OPGC, Banharpali, Jharsuguda, ODISHA desires to assess the domestic market interested in procurement of Gypsum.

### **B. Expression of Interest:**

IB thermal power station, OPGC, Banharpali, Jharsuguda, ODISHA invites “Expression of Interest (EOI)” for assessing the market response for short listing of purchasers/ agencies for further course of action like Long term tie up/ MoUs/ Agreement/ Tendering or any combination of these three options, for procurement of Gypsum from FGD plant of Ib thermal power station with having purity of minimum 85%, moisture content less than 10%, Chloride content lesser than 100 PPM. The interested parties can also mention whether they are Gypsum wall board manufacturer or glass fiber reinforced gypsum (GFRG) panel manufacturer. In such a case, the total amount of Gypsum produced can be given to such purchaser/ agencies/ companies on long term basis/ MOUs/ Agreement.

Interested parties are requested to refer the terms and conditions of EOI and submit their EOI accordingly. Details of IB Thermal Power Station, OPGC, Baharpali, Jharsuguda, ODISHA along with address, daily/ Monthly/ Yearly production of Gypsum is provided in Annexure-I. Purchasers/ agencies shall submit their EOI based upon the required quantity of Gypsum.

**Terms and conditions for the Expression of Interest (EOI):**

1. IB Thermal power station, OPGC is likely to be commission with wet limestone based flue gas desulphurization (FGD) system in the year 2023-24.
2. The scope of EOI is for sell of Gypsum of the order of 350 MT/ Day from OPGC Phase-I & 1000 MT/ day from OPGC-II phase.
3. The interested parties shall submit EOI depending upon the available/ tied up capacity of interested purchasers/ agencies.
4. The interested purchasers/ agencies shall make their own arrangement for transportation of Gypsum from IB Thermal power station, OPGC.
5. It may be noted that submission of EOI does not, in any way constitute any kind of commitment on the part of IB Thermal Power Station (OPGC).
6. OPGC, reserves the right to assess the capacity/ capability of the applicant and viability of proposal, based on verification of documents and if required, cross verification for establishment of the capable applicant(s). If the process adopted and practice followed is not as per the above terms and conditions by the purchaser, OPGC shall have the rights to cancel the contract at any time.
7. OPGC reserves the right to accept or reject any or all the applicants or cancel the EOI process without assigning any reason what so ever, in case situation arises, and in such a case no applicant / intending applicant shall have any claim arising out of such action.
8. Interested purchasers/ agencies shall ensure proper care and constant vigil of transportation activities for any damages to any existing properties, which may results in Environmental hazards in any way, in case of award.
9. Interested purchasers/ agencies shall have to abide by the guidelines of central/ state government and ensure compliance, in case of award.
10. All applicable safety norms to be followed up by the interested parties/ agencies while loading, handling and transportation of Gypsum, in case of award.
11. All possible measures will have to be taken by the interested parties/ agencies to avoid pollution while transporting, in case of award. No spillage of Gypsum will be allowed.
12. Transportation of Gypsum from production area will be the responsibility of the respondent.
